The new films create a uniform rice paper appearance not typically found in North America. Light is dispersed softly, rendering a high-class, tranquil atmosphere for interior glass partitions or the inside surface of windows. The Fasara films offers the opportunity to immerse ourselves in the aesthetic serenity distinctive to the Japanese culture while still maintaining the outstanding quality provided by 3M technology.

Product Description

3M[™] Fasara Interior Design Films are translucent graphic films that are recommended for interior glass and exterior glass (second surface) window applications. These translucent films are made of durable polyester with a matte surface for privacy, decorative and architectural applications. The Fasara[™] films can also be applied to acrylics and heat dried polycarbonates (oven baked at least 14 hours at 180 degrees F to remove moisture from polycarbonate). The total nominal thickness is 2 mils (3.0 to 3.5 mils including liner depending on film type). The films are manufactured with a silicone liner to protect the clear pressure-sensitive adhesive that can be dry laminated or wet applied to glass. The film can be cut to create unique appearances and can be removed to accommodate changes if

desired. The rice paper and textured films resist the oils from fingerprints to reduce maintenance and protect the installation.
